## THE RECTOR

**Having regard** to Rector's Decree Rep. n. 411-2019 Prot. n. 20540 dated May 17<sup>th</sup>, 2019, published in the Gazzetta Ufficiale n. 42 on May 28<sup>th</sup>, 2019 by which a selection procedure has been held to recruit **n. 3 fixed-term (3 year) full-time Researchers** in compliance with Art. 24, Par. 3, Letter b) of Italian Law 240/2010 at various Departments;

**Having regard** to the corrigendum to the selection procedure mentioned in the previous paragraph, issued with Rector's Decree Rep. n. 662-2019 Prot. n. 28420 dated July 3<sup>rd</sup>, 2019, concerning the correction of paragraph 1, Art. 8 of the same Rector's Decree;

**Having regard** to Attachment 2 to Rector's Decree Rep. n. 411-2019 Prot. n. 20540 dated May 17<sup>th</sup>, 2019, concerning admission requisites for the Academic Recruitment Field 10/C1 - Cinema, Music, Performing Arts, Television and Media Studies, Academic Discipline L-ART/06 - Cinema, Photography and Television;

**Noted that** the requisites required in *Research and Teaching activities* and in *Further scientific and teaching qualifications* are restrictive compared to what indicated in the description of the Academic Recruitment Field 10/C1 and the Academic Discipline L-ART/06;

**Considering** that it is necessary to correct the selection procedure issued with Rector's Decree n. 411-2019, Prot. n. 20540 dated May 17<sup>th</sup>, 2019;

## DECREES THE FOLLOWING

**Art. 1** – Attachment 2 of Rector's Decree n. 411–2019 Prot. n. 20540 dated May 17<sup>th</sup>, 2019 is corrected as follows:

### ATTACHMENT 2

**Academic Recruitment Field:** 10/C1 - Cinema, Music, Performing Arts, Television and Media Studies

**Academic Discipline:** L-ART/06 - Cinema, Photography and Television

**Place of work:** Department of Human Studies

**Funding:** 0,5 P.O. Fund for financing the Excellence Departments 2018-2022

**Teaching activities:** The selected candidate shall teach the courses related to the Academic Discipline L-ART/06 offered within the Bachelor's Level Degree and the Master's Level Degree of the Department, focusing on the central themes of the project of the Department of Excellence. He/she shall also be in charge of integrated, laboratory and seminar activities, Ph.D. courses, incoming and mid-term orientation activities, and in general tutoring for students.

**Research activities:** The selected candidate shall apply his/her skills in history of cinema to the dynamics of new contemporary media and to the comparison with other arts and knowledge, key issues of the Project of Excellence "*Arts, languages, media on transcodification*".

**Further scientific and teaching qualifications:** The selected candidate is expected to have skills related to theoretical and historical aspects of audiovisual communication media, in particular cinema and television, concerning both techniques and special targets of some typologies of products

of cinema in contemporary society – such as intermedia practices and creativity in the web - and the relationship between audiovisual culture and literary, historical, philosophical, pedagogical, scientific and technological disciplines.

**Assessment criteria:** the Examining Board will assess the candidate's scientific publications and overall CV according to the following criteria:

- a) Originality, innovation, rigorous methodology and relevance of the publications submitted;
- b) Analytic determination of the candidate's individual contribution in co-authored publications;
- c) consistency of the candidate's activity with the subjects included in the academic recruitment field object of the selection procedure with particular reference to the profile indicated by the Department;
- d) scientific relevance of editorial classification of the publications and their diffusion within the national and international scientific community;
- e) temporal continuity of scientific production also in relation to the evolution of knowledge in the specific academic field;
- f) consistency of the candidate's scientific profile with what required in the selection announcement in the outline of the scientific and teaching profile as well as in "Further scientific and teaching qualifications".

The following qualifications will anyhow be specifically considered in the comparative assessment:

- a) Ph.D. and other research grants;
- b) participation in national and international research projects;
- c) organization of scientific events;
- d) collaboration with highly regarded journals or series.

**Maximum number of publications:** 12 (twelve).

**Foreign language requisite:** English

**Art. 2** – The deadline for application submission is re-opened, according to what specified in Art. 3 of the selection procedure, for **10 days** from the day following publication of the announcement of the present corrigendum in the Gazzetta Ufficiale.

**Art. 3** – The applications submitted within the deadline of the previous corrigendum to the selection procedure announcement set for July 19<sup>th</sup>, 2019 shall remain valid.
